

# Aussie Quick Quilt Retreat Competition

## Terms & Conditions

### Promotion Period

**Commencement Date:** 12.01am AEDT on 1<sup>st</sup> July 2018

**Closing Date for Purchase:** 11.59pm AEST on 9<sup>th</sup> September 2018

**Closing Date for Entries:** 11.59pm AEST on 16<sup>th</sup> December 2018

10 finalists will be chosen by 9<sup>th</sup> January, with live Draw 2PM AEST on 22<sup>nd</sup> January 2019

### Who can enter

Anyone who has bought an Aussie Quick Quilt Kit between 1<sup>st</sup> July 2018 and 9<sup>th</sup> September 2018

### How to enter

During the Promotion Period, entrants must make a finished quilt in the modern traditional Aussie Quick Quilt methodology as per our Instructions and movies. (e.g. No hand Sewing)

For the purpose of this competition, an Aussie Quick Quilt Kit is defined as any full-priced Kit purchased from the AQQ website or by specific order from Leanne or Emily, or any purchase where the receipt specifically mentions Valid for Competition Entry. Vouchers

The Quilt must be completely finished (in AQQ methodology).

Entrants must provide a photograph/scan of their proof of purchase during the Promotion Period with their entry details along with at least five high quality digital photographs of the finished Quilt. One photograph must be a flat shot of the entire Quilt front, one photograph must be of the back and the third of the Basting Stage. Two photos must be close-ups of the top right corner front and back, clearly showing one of the three AQQ methods of binding, Square Binding, Back Binding or Mitered Binding. Additional photographs will be accepted if necessary (e.g. to show detail in the quilt). Entries or photographs depicting scenes unsuitable for public display will not be eligible to win any of the prizes.

No actual Quilts are to be submitted by entrants. No photographs submitted will be returned to entrants. Entrants to email [leanne@aussiequickquilt.com](mailto:leanne@aussiequickquilt.com) and submit their full name, address, email address and contact phone number with their photographs and proof of purchase.

## Prize Details

\$100 AQQ Gift vouchers + gift packs will be awarded to the remaining finalists.

## **Prize Selection Method**

Up to 10 Quilts will be chosen, with a random draw from these 10 quilts to select the winners.

(This will, in true Aussie Quick Quilt fashion, allow the best of any level of quilter to have an equal chance)

Judgement of the 10 best entries will be undertaken by a panel of judges. The judges will base their determinations on the following criteria –60% AQQ Methodology, 30% workmanship, 10% original Creativity e.g. applique to highlight. The results are final, and no correspondence will be entered into.

## **Initial Prize Selection**

10 finalists will be chosen by 9<sup>th</sup> January, with live Draw 2PM AEST on 27<sup>th</sup> January 2019, with the winners to be notified by phone, and results posted on the AQQ Website and Facebook Page and published in the next available Courier Mail.

## **The Promoter**

1. The above table forms part of these T&Cs and contains details concerning when, who and how to enter; the time, place & method of prize selection; prize details; and who the promoter is and any permit details. Products required to be purchased for entry, lay by purchases or payments will not be counted for entry purposes.
2. The Promoter, its associated agencies and companies, and employees of the Promoter and its associated agencies and companies and the immediate families of such employees are ineligible to win the prize.
3. All prize selection/s are final, and no correspondence will be entered into.
4. The winner/s will be notified where possible by telephone on the day of the relevant prize selection, and in writing by email as far as practicable within two business days and no more than five business days after the date of the prize selection. The name of the winner will be published on the Promoter's website and on the Promoter's Facebook wall and published in the next available Courier Mail.
5. The winner/s consents to their name, town/suburb of residence and a photo being published by the Promoter including, but not limited to, being published on the Promoter's Internet site, social media pages, in associated stores and in marketing material as a condition of acceptance of the prize. Further information will be published only with the permission of the winner.
6. The prize/s cannot be exchanged for any other prize without written permission from Aussie Quick Quilt, and except in the case of cash prizes, cannot be exchanged for cash. 10. The prize is subject to availability and it must be booked at least 1 month prior to travel / for departure prior to Selected Retreat ("Redemption Deadline"). To redeem the prize, the winner shall provide the Promoter with the full name of the travelers as appears on their passport/I.D. and confirm preferred dates of travel 1 month prior to the preferred departure date. Reservations are subject to availability at the time of reservation. No changes to itinerary and accommodation is permitted once the Promoter has confirmed dates of travel and accommodation or if allowed, it may be subject to a surcharge or administrative fees which shall be borne by the winner. If the winner fails to redeem the whole or part of the prize within the Redemption Deadline, the relevant unredeemed portion of the prize will be forfeited, and cash will not be awarded in lieu of prize.
